CALL TO ORDER Mayor Dayle called the meeting to order at 6:31 pm.

MINUTES

51/21 **BRICKLEY:** That the minutes of the June 9th, 2021 meeting be approved. **CARRIED**

ACCOUNTS

52/21 **POTTER:** That the June accounts paid by cheques numbered 3670 to 3683 and EFT #'s 2107, 21062 & 21063 totalling \$36,252.29 and attached to these minutes be approved. **CARRIED**

FINANCIAL STATEMENTS

53/21 **BRICKLEY:** That the Bank Reconciliations and Financial Activities report for the month of June, 2021 be accepted as presented. **CARRIED**

MR. DAN COLE OF CACTUS & COLE HOLDINGS ATTENDED THE MEETING.

Mr. Dan Cole of Cactus and Cole Holdings attended the meeting at 6:55 pm and inquired if council had any objections to his applying for a liquor license for his property on Lots 15 to 17, Block 7, Plan N334 as well as a request for a public meeting with the community so that he could publicly discuss his plans for the western theme for main street.

54/21 **POTTER:** That we write the Sk. Liquor and Gaming Commission and advise them that we have no objection to Cactus & Cole Holdings applying for a liquor license for Lots 15 to 17, Block 7, Plan N334. **CARRIED**

55/21 **TARR:** That we not organize a public meeting for Cactus & Cole Holdings as council does not feel that this is a council concern. They would encourage Mr. Cole to organize and hold a public meeting on his own. **CARRIED**

M. BERTALON REQUEST FOR TAX REDUCTION

Murray Bertalon requested an abatement of the municipal taxes for 2020 on Lots 19 & 20, Block 4, Plan AL2307 as they had removed the house on the property and installed a canvass shop.

56/21 **POTTER:** That we not abate the taxes on Lots 19 & 20, Block 4, Plan AL2307 as the canvass shop has been assessed at almost the same assessment as the previous buildings were so it would result in the same taxation. **CARRIED**

ISSUE PAYMENT TO COMMUNITY HALL FOR eTRANSFER

57/21 **TARR:** That we issue a payment in the amount of \$40.00 to the Kennedy Community Hall as payment in full for the eTransfer we received from Ms. Caroline McMillan for her walking in the hall for the month of April, 2021. **CARRIED**

DISCUSSION ON EXTENDING TAX DISCOUNT DUE TO LATENESS OF NOTICES'

58/21 **BRICKLEY:** That, due to the extended appeal time and the administrator having worked at the lagoon installing valves resulting in the tax notices being mailed late, we extend our discount periods for one month. This means that the 5% discount will be offered until August 31st, 2021; the 4% discount will be offered until September 30th, 2021 and the 3% discount will be offered until October 31st, 2021. The regular discount periods will be returned to normal for 2022. **CARRIED**
