CALL TO ORDER Mayor Dayle called the meeting to order at 6:28 pm.

MINUTES

69/21 **POTTER:** That the minutes of the August 11th, 2021 meeting be approved. **CARRIED**

ACCOUNTS

70/21 **TARR**: That the August accounts paid by cheques numbered 3704 to 3716 and EFT #'s

21081, 21082 & 21083 totalling \$38,471.16 and attached to these minutes be approved. **CARRIED**

FINANCIAL STATEMENTS

71/21 **WARNER:** That the Bank Reconciliations and Financial Activities report for the month of

August, 2021 be accepted as presented. CARRIED

INSTALLATION OF DOORS IN FIRE HALL

Two quotes were presented for the installation of overhead doors for the fire hall. These doors had been donated by Loraas Disposal but did not include any tracking or other hardware. One quote was from Eagle Overhead Doors and was broken down into two parts. The first part was for the village's two doors to be repaired and was in the amount of \$4,354.20. The second part was for the installation of the overhead doors and was in the amount of \$21,996.95 for a total quote of \$26,350.85 taxes included. The second quote was from Rod Vance Construction and was in a single quote for the entire work, both the village doors and the overhead doors, and was for \$38,200.00 plus taxes.

Mr. Derrick Hoehn completed a surprise inspection of the Kennedy Lagoon on Wednesday, September 8th. At that time he and the administrator were talking about locating the manholes for the sewer line leading to the lagoon. Derrick did not think the village should be allowing farming over the manholes in case the equipment catches and damages a manhole. He said it could be very costly for the village.
