CALL TO ORDER: Mayor Brendon Dayle called the meeting to order at 6:29 p.m.

ABSENCE OF COUNCILLOR JACK WARNER

174/23 **BRICKLEY:** That the absence of Councillor Jack Warner be acknowledged and granted at this time. **CARRIED**

- On behalf of Village Foreman Glenn Hofos, Acting Administrator Jennifer McMillan reported that the winterizing of Tom Cummin's property took 3 hours to complete. Also that help is needed with the repairs to the fire hall which Councillor Linc Brickley will help complete. Glenn may get rig work the last week of October, and will make up the time in November if needed. Glenn also asked if he was needed for snow removal.
- Mayor Brendon Dayle notified council and administration of breaker repair work done by Back Country Electric on the Trailer Park Well Pump over the October 7 8, 2023 weekend due to low water pressure.
